____ In order to protect the public, staff, volunteers, and the animals, volunteers will report any signs of animal aggression or illness to a staff member immediately. Any bite from an animal must be reported to staff *immediately*.

____ Social Media Rules:

- No photos or videos of animals, staff, volunteers, facilities, or vehicles may be taken or shared.
- Volunteers may not speak on behalf or represent themselves online as spokespeople for GCSO Animal Services, on any social media platform.

____ Volunteers help at the direction of the GCSO Animal Services staff only.

____ Any complaints, concerns, or suggestions must be directed to the Animal Services Supervisor.

____ Volunteers understand that there are unfortunate circumstances when some animals have to be euthanized. GCSO Animal Services generally euthanize animals who have veterinary needs that cannot be met by the resources available or whose temperament poses a threat or injury to people or other animals. Volunteers are never asked to be part of the process but it is important they can accept staff decisions concerning euthanasia when it is necessary.

____ **VOLUNTEERS MUST FOLLOW ALL GCSO ANIMAL SERVICES GUIDELINES. FAILURE TO COMPLY WITH THESE GUIDELINES WILL RESULT IN IMMEDIATE CESSATION OF VOLUNTEER PRIVILEGES.**
